- A non-refundable registration fee of \$75.00 is due at the time of registration.
- September tuition is due by August 15th, in order to hold your child's space.
- Yearly prepaid registration and tuition must be paid in full at the time of registration, and a 5% discount will be applied.
- Monthly tuition payments are due on or before the first of the month. Monthly payments received after the fifth of the month will be assessed a late fee of \$10.00.
- Payments can be made by personal check, money order, cash, and automatic withdrawal. No PayPal or credit cards will be accepted.
- Returned checks (NSF) will be surcharged a \$35.00 fee. If 2 checks are returned for NSF, personal checks will no longer be accepted, cash only payments, thereafter.
- There is an overtime fee for late pick up. If your child has not been picked up ten minutes after class has ended, there is a overtime charge of \$10.00. Additional overtime charges of \$10.00 is applied for each ten minute interval thereafter.
- Parents are responsible for each month's tuition, regardless of absences due to illness or family travel. The school's budget and teacher salaries are based upon full enrollment.
- Parents agree to participate in fundraisers to earn \$100. profit for the school. Parents can opt to make a one time payment of \$100.00 to the school in lieu of participation.
- Two weeks' written notice must be given to the school in the event a child is to be withdrawn for any reason. Parents are required to pay for those 2 weeks regardless of when the child stops attending preschool.
- Proof of current immunizations is required prior to admission.
